## SUMMARY OF PRESENTATIONS AND ISSUES DISCUSSED

The Local Consultant continued presenting the preliminary results from desk review on the Global Fund guideline with related documents of the CCM Positioning process and mapping exercise of the existing health sector coordinating bodies and platform as below:

### Background

- Global Fund Guideline and CCM Policy
  - o Position CCM within existing health platform
  - Engage DPs/CSO in CCM positioning
  - o Ensuring Investment in 3 ATM programs
  - o Positioning pathway

# Base on future direction of the national health sector

- o Simplification structure
- o Align with in the existing health structure
- o Implementation Vientiane Declaration on AIDs effectiveness
- o Not create a parallel structure with the existing platform

## Principles CCM positioning option and successful

- Principle CCM positioning options (Existing CCM aim to different positioning options):
  - o Align CCM with other donor 's program in a single coordinating platform
  - o Transfer the CCM structure with in a national body
  - Shift CCM function and principles within existing body(ies) and set up an aligned health program coordination
- Successful CCM positioning (The end of positioning pathway)
  - Multisectoral partnership
  - o Improved coordination
  - Effective health investment
  - o Improved grant oversight
  - o Regular monitoring
  - Advocacy for realization of domestic investments

### **Propose options**

## 4 options of CCM positioning integrated in the existing structures

- Option 1: Positioning CCM in Health SWC, health reform Samsang
- Option 2: Positioning CCM in HANSA committee
- Option 3: Positioning CCM in Technical committee for PCRCM Covid 19
- Option 4: Positioning CCM in Natural disaster Prevent & control

- Revising and finalizing the mapping exercise
- Revising and finalizing the executive summary report
- Develop PPT of the report
- Develop CCM positioning plan with the CCM positioning option selected

### Key comments from the meeting:

The participants had long discussion on preliminary findings of mapping exercise and different options for CCM positioning in the existing national committees of the health sector:

- Regard to the list of 17 existing health committees included in the mapping exercise, the representative from CMPE proposed to add one more committee for the national Malaria program;
- Conflict of interest and engagement of the multi-sectors, including NGOs, CSOs and key populations are the key principle of the Global Fund. If CCM is being transferred to the existing committees of the Ministry of Health, which committee will be most suitable? how to resolve conflicts of interest? and how to engage the NGO and CSOs in the new structure. Regarding conflict of interest, some participants observed that the Global Fund has some level of flexibility in the recent year by allowing a representative from the MOH (PR) be nominated and elected as a CCM Chair which has shown effective leadership and ownership of the Government in funding management;
- HANSA Committee (option 2) and Technical Committee for PCRCM COVID -19 (option 3) are ad-hoc committees and were set up for specific project and task. HANSA Steering Committee was established for cooperation between the donors, government sectors and partners to implement the health programs, including HIV/AIDS and Tuberculosis but not include Malaria. The committee may be finished if there is no further funding source. Technical Committee for PCRCM COVID -19 was established specifically for managing and controlling the outbreak of COVID-19. it is not sure that how long the Global Fund will continue this funding modality as the COVID -19 outbreak situation may be changed;
- To promote ownership, sustainability, strategy of health sector reform and the national programs in the fight against HIV/AIDS, Tuberculosis, and Malaria, the meeting agreed to integrate CCM into the Health SWC, Health Sector Reform, Samsang Committee, as the committee has a strong structure and

- includes all programs of the health sector reform. The governance body chair by Minister of Health and co-chair by Development Partners (WHO Representative and Japanese Ambassador). At the current stage, CSOs representatives have been participated at a policy level of the committee as an observer but the level of engagement of CSOs can be discussed later;
- However, the participants note that the structure and operation of the Health SWC, Health Sector Reform, Samsang Committee are not yet complete as planned, so the Ministry of Health should be encouraged to improve the organization and operation of this committee. Furthermore, this committee should manage conflicts of interest in line with Global Fund policies and facilitate the involvement of CSOs as possible. The WHO will continue discussing with the MOH Cabinet and DPC to strengthen this committee and will share the updated information later to all key stakeholders.
