Quality Management Staff	Following's DPF response, we understand the recruitment of the QMU staff at NCLE is in the process of finalization. DPF should share an expected timeline for the finalization of this recruitment.	As per coordinated with the NCLE regarding this issue, NCLE has already finalized the recruitments of QMU staff. In this regard, we would like to inform you that the documents had already been approved from the DCDC and DPF on May 29, 2025, and we have also submitted the documents to the Minister of Health for approval at the same day, and the Minister has already approved on June 5, 2025. Currently in the process of preparing documents for the negotiation and direct contract with the company.
Health Product Procurement review	Following NPCO request for an extension to response to each of the recommendations of the report, we propose Friday 06, June. Please let us know if this is enough time or kindly suggest a timeline.	We have already shared our response to the GF June 9, 2025. <b>(Done).</b>

In this regard, we would like to inform you that the documents had already been submitted to the Minister of Health regarding this issue on May 29, 2025. Currently, the Minister has already signed the letter by today morning, and we will also submit it to the MOFA by today afternoon.
Request for refund	The Global Fund requested the MOH to refund USD 229,935.23, related to the C19RM cash balance and the non-complaint expenditure. Please refer our communication sent on 30 May 2025 for further details.	Yes, this is well noted. Currently, we are reviewing related documents, and we will get back to the GF as per the timelines accordingly.

HANSA External Audit	We understand from the timelines shared previously that the audit fieldwork took place from 12 – 23 May. Please share an update on the audit process and timelines.	Yes, the previously shared audit fieldwork would be taking place from May 12-23, 2025. However, the audit fieldwork has been postponed from May 12-23 to May 15-28, 2025 at the DPF/NPCO office, and the field visits to each relevant stakeholder from June 2-6, 2025 at CHAS, NTC, MCHC, Vientiane Capital Health Office, Xaythany district, Pakgeum district, Naxaythong district, Vientiane province, Pheung district, Hinherb district, Kasi district, and Vangvieng district (Done).
C19RM fixed asset verification	Thank you for completing the final physical verification of C19RM fixed assets and sharing a revised asset registry. However, DPF is expected to respond to each of the recommendations outlined in the letter shared on 22 January 2025 (attached to this email).	Yes, we would like to inform you that we are now working on it, and we expect to share it with the GF by Monday 23 <sup>rd</sup> June 2025.

Procurement Monitoring	We understand that DPF/NPCO is still awaiting a response from the supplier regarding the training and installation timelines of the BACTEC MGIT 960 system. We would like to request an update on the timelines for installation and training as soon as it is received.	As per coordination with NTC, the installation of the BACTEC MGIT 960 system has already completed, but still waiting for the Calibrator kit code number 445999 from GDF, which will be delivered with the TB tests kits within June. The supplier and TB Lab team have plans to train in July 2025.
Procurement of ARVs	DPF confirmed that the official documents related to the procurement of ARVs have been submitted to the DCDC for review and approval. We understand that upon DCDC approval, DPF will prepare the request for MOH approval. Please provide an update on this process. DPF should expediate the process for the approval of the documents to ensure that the ARVs are ordered in Wambo with sufficient time to meet the delivery timeline requested by CHAS.	Yes, we would like to inform you that DPF/NPCO had already placed the requisition/order for the ARVs procurement in the GF system (Wambo) on May 5, 2025. The placing order was under the requisition no. 28871. Currently in the process of approval via Wambo.
